This Contract (the "Contract") is entered into on this 14<sup>th</sup> day of September, 2021, by and between

**HYDROCHINA INTERNATIONAL ENGINEERING COMPANY LIMITED PAKISTAN**  
(Hereinafter referred to as the "Contractor" which expression shall include the successor, heir, executor, administrator and assigns) of the one part, and

**ALI PETROLEUM SERVICES** having its primary place of business at Main Gate Railway Workshop, Pathan Colony, American Quarter Hyderabad. (Hereinafter referred to as the "Supplier" which expression shall include the successor heir, executor, administrator and assigns) of the other part

Contractor and Supplier shall be jointly referred to as "Parties".

A. WHEREAS the Contractor is the EPC Contractor for Master Green Energy Limited Wind Power Project of 50 MW (hereinafter, referred to as "Project"); and the Contractor intends to supply the Diesel at Master Green Site located in Jamshoro, Sindh;

B. WHEREAS the Supplier is ready, willing and able to undertake to provide Diesel Supply services of Master Green Project Site.

NOW THEREFORE the Parties have decided to enter into the Contract governed under following clauses:

## **1 DEFINITIONS**

---

In these conditions, except where the context otherwise requires:

- (a) Contract: The Contract signed by the Parties
- (b) Effective date: the date this Contract signed.
- (c) Commencement Date: Commencement Date is 14<sup>th</sup> September 2021 agreed on by the Contractor and the Supplier.
- (d) Firm price: the price is a firm price that is only subject to adjustments when both parties agreed in writing.
- (e) Party: The Contractor or Supplier, as the context requires.
- (f) Parties: The Contractor and the Supplier.
- (g) Site: Master Green Energy Limited Wind Power Project according to the Contractor's requirement.
- (h) Work: The Supplier shall Provide Diesel supply services according the requirement mentioned in section-4.





## **2 INTERPRETATION**

---

Words importing persons or parties shall include firms and corporations and any organization having legal capacity.

Words importing the singular only also include the plural and vice versa where the context requires.

The headings and marginal notes in the Conditions of Sub-contract shall not be deemed part thereof or be taken into consideration in the interpretation or construction thereof or of the Sub-contract.

## **3 GENERAL PROVISIONS**

---

### **3.1 Governing Law**

---

The Contract shall be governed by and construed in accordance with the laws of location of Contractor's headquarter. If there's additional cost to Supplier due to any change in law, include but not limited with the increase of Withholding Tax, the Supplier shall bear the cost.

### **3.2 Language**

---

The language of the Contract and of all communications between the Parties shall be English.

### **3.3 Notices and Communication**

---

Any notice, request, consent, or other communication made between the Parties pursuant to the Contract shall be in writing and shall be deemed to have been made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by telex, telegram, e-mail or facsimile to such Party at the address specified in the Contract, or one week after having been sent by registered post.

### **3.4 Confidentiality**

---

Both parties shall keep all commercially sensitive information obtained by them in the context of the Contract confidential and shall not divulge it without the written approval of the other Party.





### **3.5 Sole agreement**

The Contract constitutes the sole agreement between the Parties for the provision of Diesel supply Services and no representation not contained therein shall be of any force or effect. No amendments will be of any force or effect unless reduced to writing and signed by both Parties.

### **3.6 Indemnification**

The Supplier shall indemnify the Contractor against all actions, suits, claims, demands, costs, charges and expenses arising in connection therewith from the negligence, infringement of intellectual or legal rights or breach of statutory duty of the Supplier, his Contractors, agents or servants, or from the Supplier's defective arms or workmanship.

## **4 MAIN RESPONSIBILITIES OF THE SUPPLIER**

### **4.1 Main Responsibility**

The Supplier shall, in accordance with the Contract from the signing of Contract,

- a) Supply the required quantity of diesel to the designated project site facility.
- b) Quality of diesel shall be as per the standard diesel provided by OGRA.
- c) Diesel shall be delivered in 24 hours from the date of placement of order through formal or informal communication channel.
- d) Any difference found in the quality and quantity of supply shall result in penalty or termination of contract.
- e) Diesel supply vehicle driver shall have a valid driving license.
- f) Supplying vehicle shall be in a good condition and maintained by the supplier timely.
- g) Supplier shall be responsible to obtain diesel storage permit from Explosive department of Pakistan, which shall be valid for at least one year.
- h) WHT exemption certificate shall be provided to along with the invoices otherwise tax will be deducted.
- i) Supplier shall respect and follow all the HSE requirements recommended by the Contractor and client team.
- j) Supplier shall supply the diesel as per the schedule provided by the Contractor. Late deliveries will result in deduction of 10% of the payment of the order and also in termination of contract.

## **5 COMMENCEMENT AND COMPLETION**

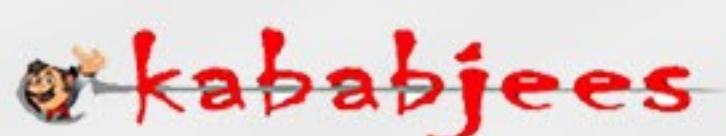
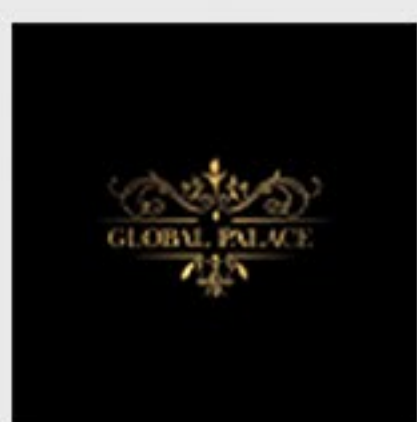
